- b) Medical report showing the treatment whenever the Prisoner/Inmate falls sick.
- c) Medical records of treatment provided to the Prisoner/Inmate 72 hours prior to death or precipitating
- d) Pathological Test Report of HIV/AIDS/Infection of Tuberculosis, if the prisoner/inmate was suffering from it.
- e) Inquest Report, Post mortem
- f) Chemical Analysis /Histo-pathological Report
- g) Final Opinion regarding cause of death
- h) District Magistrate / Sub-Divisional Magistrate Report under Section 176 Cr.PC or 194 B.N.S.S as applicable
- i) Final Outcome/Status of Departmental /Disciplinary Action if any;
- j) C.I.D (Crime)/ Crime Branch Report if any.
- k) If Encounter matter, ballistic report received or not
