लोकमत न्यूज नेटवर्क मुंबई : मुंबई शहर आणि उपनगरांतील व्यक्तींकड्रन होत नसून समाजर्कटकांकडून नाही. त्याची तोडफोड करण्यात आली त्यामुळे पर्यावरण क्षेत्रात काम आले आहेत. उद्यानातील शौचालय करणाऱ्यांनी याबाबत नाराजी व्यक्त गेल्या पाच ते दहा वर्षांपासून बंद आहे. केली आहे. शिवाय उद्यानाच्या देखभाल दुरुस्तीकडे प्राधान्याने लक्ष द्यावे, अशी मागणी देखील केली आहे.

मिळालेल्या उद्याने, मैदाने वाचविण्यासह त्याच्या माहितीनुसार, पवई उद्यानाची अवस्था सुशोभीकरणासाठी महापालिका अत्यंत दयनीय झाली आहे. झुडपांमुळे सातत्याने प्रयत्न करीत असतानाच मुख्य प्रवेशद्वाराची अत्यंत वाईट दुसरीकडे पवई उद्यानाची अवस्था अवस्था झाली आहे. येथील आजघडीला अत्यंत दयनीय झाली साहित्याची चोरी झाली आहे. आहे. उद्यानाची देखभाल दुरुस्ती नीट उद्यानातील एकही स्ट्रीट लाईट अखंड उद्यानाची नासधूस केली जात आहे. आहे. त्यातील दिवे काढून नेण्यात अत्यंत गलिच्छ अवस्थेत असलेल्या शौचालयात नळ नाही, अशी परिस्थिती येथे आहे.

- २. We noticed news appeared in Marathi News paper Lokmat dated 09.11.2022 on Page 3 (Hello Mumbai) under caption "पवई उद्यान आहे की भंगारचे दुकान?".
- 3. It is stated in the said news that Municipal Corporation of Greater Mumbai failed and neglected to maintain Powai Garden for last several years. Not only that even WC are in dilapidated condition, not a single street light in the said garden is working. Entire garden space is used to store scrap material. This is very unfortunate in Powai locality, Corporation failed and neglected to maintain the garden which is essential for public at large to maintain their health and peace. If it is not maintained properly that amounts to a violation of human rights.
- Considering these facts the following order is passed:
 - a) Office is directed to issue summons to the Municipal Commissioner, Municipal Corporation of Greater Mumbai,

- i. When the Powai garden as described in the news dated 09.11.2022 constructed?
- ii. Who is maintaining the said garden?
- iii. How many gardeners are appointed to maintain this particular garden?
- Who is storing scrap material in the said garden
- What is the present condition of WC in the said garden along with photograph
- vi. How many street lights are provided in the said garden? Whether those are in working condition, if it is not in working condition, since when same is not working?
- vii. What about the fencing and boundary wall of the said garden?
- viii. The name of the person and designation who is supposed to maintain and take care of this garden.

ORDER

(Per: Justice K. K. Tated, Hon'ble Chairperson)

Advocate appearing on behalf of Corporation filed affidavit dated 15.06.2023. Same is marked as Ex. 'C'.

- 2. This suo motu complaint initiated on the basis of news appeared in Marathi newspaper dated 09.11.2022 with heading "पवई उदयान की भंगाराचे दुकान". After summons to the Corporation, they filed affidavit Ex. 'A' Ex. 'B' & Ex. 'C'.
- 3. In Ex. 'B' it is stated that they spent approx Rs. 3.5 lakhs to carryout minor repairs. Para 2, 3, 4 of Ex. B' reads thus:
 - "2. I say that, earlier W. C. was in the damaged condition however the Respondent has carried out the minor repairing and painting work. I say that the respondent has appointed the person for cleaning for toilet on the regular basis. I say that the overall

cleaning of the W. C. is carried out regularly. The painting work of toilet block is completed. I further say that beautification done by planting shrubs and raising lawn around toilet block.

- 3. I say that watering to plant is done regularly by the employee of Asst. Engineer (Outside City) Trunk Main. Hereto annexed and marked the copy of photograph of present condition of garden area as an Annexure I colly.
- 4. I say that the approximately Rs.3.5 lakhs is spent by the respondent to carry out minor as well as the major work in the toilet and also flood lights, non working light fixtures are repaired and replaced. I further say that other minor work also carried out by this department. Hereto annexed and marked the copy of expenditure as an Annexure II colly."

In Ex. 'C' they stated that they decided to carry out renovation of entire garden. Para 6 of the affidavit reads thus:

"6. I say that the Powai Garden is proposed for beautification work including civil, electrical and mechanical work. I say that for the said work BMC has invited the tender on dt. 19/05/2023 and process of opening of packet A, B is completed for civil work and after these the lowest bidder will be appointed by the BMC and then work order will be issued soon for following work.

Civil Work/Scope of Work:-

- 1. Repairs to damaged MS grill over surrounding compound wall and restoration of compound wall.
- 2. Replacing damaged MS gates.
- 3. There is one public toilet which is situated in this park area. The park was closed for almost 02 yrs. during Covid-19 pandemic. Therefore, this toilet remained non-functional & internal pipe fittings, basin, doors etc. were damaged by thieves/anti-social elements. Now recently this park is opened for public after long time. The public toilet which is inside this park is needed to be opened by carrying out necessary repairs works. Therefore, Repairs to the

toilet block completely and maintaining cleanliness of the same for 03 yrs is proposed in this work.

- 4. Walking pathway is settled at many locations which needs to be repaired.
- 5. Repairs to the water tank to provide sufficient water for gardening use.
- The construction of compound wall is proposed at some portion of periphery of garden along Saki-Vihar road.
- 7. Developing open plot for municipal school students as play area and waiting area near Passpoli Municipal School.
- 8. Providing facilities of drinking water, providing benches for sitting, repairing damaged sitting stone tiles Renovation of security cabins etc.

Contract Period: 1 Year civil repair work + 3 years operation and maintenance of toilet block.

The copy of scope of work and tender notice is attached herewith as an Annexure III."

4. Bare reading of the Exhibits 'B' & 'C' we satisfy that Corporation has taken appropriate steps to maintain the garden. In view of these facts following order is passed:

"ORDER"

a) The present Suo Motu case stands closed and disposed off in view of Ex. "B' & 'C'.
