मजीप्राच्या पुणे, औरंगाबाद, ठाणे, माशिक, नागपूर, अमरावती या सहाही प्रादेशिक विभागांत कर्मचाऱ्यांचा ठणठणाट आहे. काही ठिकाणी मुख्य अभियंत्यांकडे या पदाच्या खुच्यां सोपविण्यात आल्या आहेत. अधीक्षक अभियंत्यांकडे या पदाच्या खुच्यां सोपविण्यात आल्या आहेत. अधीक्षक अभियंत्यांची कामे कार्यकारी अभियंता सांभाळत आहेत, तर कार्यकारी अभियंत्यांचे अधिकार उपविभागीय अभियंत्यांकडे देण्यात आलेले आहे. साइही विभागांत अधीक्षक आमियंत्यांच्या १८ जागा आहेत. त्यातील १२ ठिकाणी प्रभारी अधिकारी आहेत.

मजीप्राचे ५४ विभाग केवळ ३० पूर्णवेळ कार्यकारी अभियंते सांभाळत विकास नाम मिलावें वासाठी पाणीपुरवल मंत्री. पुल्लामंत्री आर्थीची भेट के.इन वर्ची केली. मिवेदने दिली. पाणीपुरवल व स्वच्छता विभागाच्या प्रधान सचिवांना नुकतेच पत्र पाठविलें आहे. स्वित जागा मरून या विभागाचा कारपार सुरळीत केला पाडिजे.

- i. What is the staff pattern in Maharashtra Jeevan Pradhikaran at Yavatmal?
- ii. How many vacancies are there and since when?
- iii. Within how much time they are going to fill up the vacancies so that people can get proper services?
- b) Matter to appear on board before Division Bench of Justice K. K. Tated, Chairperson and Shri. Bhagwantrao D. More, Member in Court No.1 on 12th December 2022 at 11.00 a.m.

ORDER

(Per: M. A. Sayeed, Hon'ble Member)

A suo motu cognizance u/s. 12 of the Protection of Human Rights Act came to be taken on the strength of a news reporting in Marathi newspaper 'Lokmat' of 22.11.2022 relating to the sufferings and inconvenience faced by the general public for want of sufficient staff in Maharashtra Jeevan Pradhikaran, by the government.

2. Reports on affidavits, came to be placed on record at Ex. 'A' to 'C' by the respondents. We have carefully

perused these affidavits and the documents placed on record. Infact the issue in question appears to have been duly rectified as immediate steps for filling up the vacancies in different cadres at Maharashtra Jeevan Pradhikaran unit, Yavatmal came to be taken by the respondent as reflected from para 3 of the affidavit vide Ex. 'C' which reads thus:

"3. I say that as stated in the earlier Affidavit dated 10.01.2023, in its para No. 5, it was pointed out that pursuant to the G. R. date 31.10.2022 issued by Finance Department and letter dated 20.12.2022, issued by the State Government, the Maharashtra Jeevan Pradhikaran is taking appropriate steps of Recruitment for filling up vacant posts in Maharashtra Jeevan Pradhikaran, in its all Divisions in the State of Maharashtra, including Yavatmal Division, as expeditiously as possible. I say that now I am placing on record the tentative timeline for completing the process of filling up the vacant posts as per following time schedule in all Divisions of MJP in the State of Maharashtra, including Yavatmal Division:-

a) The time required for completing the procedure of preparation of Roaster Points for Reserve Categories and approval of the same from State Government, in comformity with Government directives:- ONE MONTH.

b) After approval of Roaster, publication of Advertisement, through private agency, calling the applications of candidates against respective qualifications and the said procedure to be conducted through the Government approved private institutions:- THREE MONTHS

c) After receipts of applications and their scrutiny, the candidates will be informed schedule of written examination/oral interviews as per their respective qualifications:- TWO MONTHS.

d) The time required for completion of process of written examination/oral interviews as per Rules laid down to that regards:-TWO MONTHS."

3. In the light of the above affirmed statement, it can be safely concluded that no further enquiry in the matter is required, hence following order:

"ORDER"

a) Present suo motu stands closed and disposed off with no order as to cost.
