Not on board. Taken on board.

- We noticed news article appeared in Maharashtra Times 1. dated 16.03.2023 on Page 2 with heading "फेरीवाल्यांनी अडवली वाट; चर्चगेटच्या भुयारी मार्गात ठाण; नोकरदार, नागरिकांची कुचंबणा"
- It is stated in the said news that in Subway at Churchgate is encroached by hawkers who inspite of several complaints Corporation as well as Police Department failed and neglected There is a statement of Mr. Kiran to take any action. Sonawane, President, All India Bank of Baroda Sena Union also made complaint for removal of these unauthorized hawkers. Because of unauthorized hawkers it is impossible for the public to use the said subway.
- Considering these facts which is affecting human rights of 3. several persons day to day, Commission decided to take up this issue by Suo Moto complaint under Section12 of The

Protection of Human Rights Act, 1993. In view of the above mentioned facts, following order is passed:

- a) Office is directed to issue summons to the Municipal Commissioner, Municipal Corporation of Greater Mumbai and Commissioner of Police, Mumbai calling upon them to hold fact finding inquiry and file their affidavit in reply on or before 11.04.2023 including following points:
 - i. How many licences are granted by the Corporation to hawkers?
 - ii. Is there any Beet Marshall or any other officer appointed to keep watch on their activities, if it is appointed whether they have submitted report to that effect?
 - iii. Who is supposed to take action against encroachers in this sub way.
- b) Matter to appear on board before Division Bench of Justice K.K. Tated, Chairperson and Shri. M. A. Sayeed, Member in Court No.1 on 11th April 2023 at 11.00 a.m.

ORDER

(Per: M. A. Sayeed, Hon'ble Member)

Marathi local newspaper 'Maharashtra Times' of 16.03.2023 highlighted on the plight of the commuters at Churchgate Railway Station subway because of rampant encroachment by the hawkers. A suo motu cognizance came to be taken u/s. 12(a) of the Act of 1993. Notices were issued to the head of the stakeholder departments and initially interim report came to be placed on record by MCGM, on the basis of which detail order dated 11.04.2023 came to be passed which reads thus:

2. A suo motu action on the strength of news article Maharashtra Times dated 16.03.2023, came to be taken,

considering its gravity as police and civic authorities were blamed for their non action against the menace of the hawkers in subway at Churchgate, causing inconvenience to the commuters. Law Asst. Valvi for MCGM, has placed on record affidavit of Shri Sandeep Dhondu Kelsikar, Sr. Inspector License, Encroachment dated 10.04.2023 marked Ex. 'A'.

- 3. Pl Shri Mangesh Chavan, Marine Drive Police Station has submitted report of DCP Zone I, Mumbai dated 10.04.2023. We have gone through these affidavits as well as heard the officers. It does appear that for the present, some action has been taken against the unauthorized hawkers by removing the encroachments as well as by initiating penal action. However, a concrete action plan is required to be placed on record to control the menace and repetition of unauthorized hawking in such busy areas, as the citizen in general are the sufferers. Asst. Law Officer Valvi for MCGM and Pl Shri Chavan have undertaken to submit detail action plan report by next date.
- 4. Moreover from the report Ex. 'B' submitted by Dr. Hari Balaji N. (IPS), DCP Zone I, Mumbai it appears that a very respective action seems to have been taken against the hawkers. Infact in para 5 & 6, following explanation has been given as under:

If these being the situation, then it is rather surprising as to how such encroachments by the hawkers is been made when the report indicates that out of 21 galas only 13 are functioning while 8 are closed and secondly, penal action against ten squatters / illegal hawkers have been taken in the year 2022 while, the news article reflect altogether a different state of affair. Clarification on such ambiguity is sought from DCP Zone I, Mumbai which should be placed on record by way of affidavit on next date
Matter stand over to 08.06.2023."

- 2. Accordingly, today, Ld. Law Asst. Valvi for MCGM, Mumbai placed affidavit of Shri Ganesh Mudale, Senior Inspector, License (Ench), BMC, Mumbai affirming in para 6 & 7 of the affidavit Ex. 'C' as under:
 - "6. I say that, at present, the Encroachment removal vehicle squad of A ward is taking repeated rounds on daily basis in two shifts (i.e. One in morning and another in evening) for removal of unauthorized hawkers running their business on municipal roads and footpaths. The Licence staff of A ward one Sr. Inspector Encroachment and each shift includes 1 Inspectors and 4-5 labourers alongwith Encr. Removal vehicles. I say that after removal action taken against illegal hawkers it is regularly intimated to concerned police station for keeping vigilance.
 - 7. I say that, in order to keep the area 150 meters from Churchgate station free from unauthorized hawkers constant patrolling by the encroachment squad will be carried out to insure that the Churchgate subway and the surrounding area remain free from unauthorized hawkers. I further say that the said action of removal will remain continue and undertake to keep free from illegal hawkers and also if any unauthorized hawkers found in the said area."

Pertinent to note that the photographs of the passage in the subway clearly indicates that unauthorized illegal

occupation by the hawkers came to be completely removed and moreover, concrete steps as a permanent solution came to be taken as affirmed in para 7 of the affidavit.

3. Thus, with such concrete steps on record, we don't think any further intervention is warranted as the issue has been duly and finally resolved by the corporation. Hence following order:

"ORDER"

a) Present suo motu case stands closed and disposed off with no order as to cost.
