बदलापुरात बेकायदा दुमजली गाळ्यांचा 'पूर'

मिंधे गटासह भाजप पदाधिकाऱ्याचा कारनामा

बदलापूर, दि. २ (सा.वा.) – बदलापूरच्या बाजारपेठेत रेल्वे स्थानकाबाहेर तब्बल ३२ दुभजली वेकायदा गाळे महिनाभरात बांघण्यात आले. एकीकडे आपल्या गटात सामील न होणाऱ्या निष्ठावंतांची 'मिंघे' गटाकडून छळवणूक सुरू असताना बदलापुरातील 'मिंघे' गटासह भावपच्या बड्या पदाधिकाऱ्याच्या आशीर्वादानेच हे बेकायदा गाळे उभारल्याची चर्चा पालिका वर्तुळात सुरू आहे. इतक्या मोठ्या पद्धतीने भर बाजारपेठेत अनिधकृत बांघकाम होऊनही पालिका प्रशासनाने कोणतीही कारवाई न करता केवळ नोटीस देण्याचे सोपस्कार पूर्ण केल्याने बदलापूरमध्ये आता बेकायदा गाळ्यांच्या गोरखघंद्याचा 'पूर' आला आहे.

बदलापूर पश्चिमेला रेल्वे स्थानकाबाहेर असलेल्या स्कायवॉकला लागून महिनाभरात ३२ दुमजली गाळे उभारण्यात आले. रेल्वेने बदलापुरात होम प्लॅटफॉर्म उभारणीसाठी जागेची मागणी केल्यानंतर नगर परिषदेने स्थानकालगत असलेले गाळे तोडून ही जागा उपलब्ध करून दिली होती. मात्र आता बदलापूर नगरपालिकेची

कोणतीही परवानगी न घेता याच ठिकाणी दुमजली गाळे बांधण्याचे काम सुरू आहे. बहुतांश गाळ्यांचे बांधकाम पूर्ण झाले असून काही गाळ्यांचे प्लास्टर व रंगरंगोटीचे काम अंतिम टप्प्यात आहे. भरबाजारपेठेत मोठ्या प्रमाणात सुरू असलेल्या या बेकायदा गाळ्यांना बदलापुरातील मिंघे गटाच्या एका बड्या नेत्याचा



राष्ट्रवादीचा आंदोलनाचा इशारा

दिवसाढवळ्या अनिषकृतरीत्या थाटलेल्या या गाळ्यांवर कारवाई करण्याची मागणी राष्ट्रवादी काँग्रेसचे शहराध्यक्ष आशीष दामले यांनी कुळगाव-बदलापूर नगर परिषदेचे मुख्याधिकारी योगेश गोडसे यांच्याकडे केली आहे. बांधकामांवर त्विरृत कारवाई न केल्यास आंदोलनाचा इशाराही दामले यांनी निवेदनाद्वारे दिला आहे. बातील, असे मुख्याधिकारो योगेश गोडस यांनी सांगितले.

तसेच भाजपमधील वरिष्ठ नेतेमंडळींचा आशीर्वाद असल्यानेच त्यावर कोणतीही कारवाई होत नसल्याच्या चर्चांना उघाण आले आहे. ठाण्यात महिला आघाडीच्या पदाधिकाऱ्यांची झुणका—भाकर केंद्रे सील केली जात असतानाच बदलापुरात मात्र मिंघे गटाने भाजपच्या साथीने बेकायदा इमले रचल्याने

प्रश्न उपस्थित करण्यात येत आहे.

बांधकाम अनिधकतच

नगर परिषदेची कोणतीही परवानगी न घेता हे बांधकाम करण्यात आले असून ते अनिधकृतच आहे. याबाबत संबंधितांना नोटिसा बजावल्या असून नोटिसीचा कालावधी पूर्ण होताच अनिधकृत गाळे जिमनदोस्त केले जातील, असे मुख्याधिकारी योगेश गोडसे यांनी सांगितले.

 - a) Intervener is directed to inform the Chief Executive Officer Shri. Pramod D. Kale, Zilla Parishad, Thane and Chief Officer Mr. Yogesh Godse, Kulgaon Badlapur Nagar

Parishad in writing that the matter is kept for hearing tomorrow i.e. 17.11.2022 and they have to remain present.

- c) Matter to appear on board before Court No.1 on 17th November 2022 at 11.00 a.m.

ORDER

(Per Hon'ble Member Shri M. A. Sayeed)

Pl Shri Ankush Mhaske, Badlapur West Police Station, Shri Vishal Sawant, Rachna Assistant, Kulgaon Badlapur Nagar Parishad, Smt. Samina Shaikh, Asst. Block Development Officer, Gram Panchayat Division, Shri S. G. Rathod, Officer, Zilla Parishad, Thane present.

The present suo motu matter came to be initiated on the strength of news reporting in Marathi newspaper '6 Thane - Raigad' dated 03.10.2022 reporting about the alleged lapse on the part of the Badlapur Municipal Council in initiating demolishing steps against illegal shops numbering 32. Notices to the supervisory authorities of stakeholder departments were

issued, pursuant to which reports came to be submitted on record vide Ex. 'A' filed by Shri Kale, Dy. Chief Engineer, Zilla Parishad, Thane dated 25.11.2022. During the course of enquiry and after having heard Dy. Exe. Officer Shri Kale, following direction came to be passed by us on 28.10.2022:

"Chief Executive Officer, Shri Pramod B Kale, Zilla Parishad, Thane & Chief Officer, Shri Yogesh Godse. Present.

Yoghesh Borse, Chief Officer, Badlapur Nagar Parishad, Badlapur submits that the unauthorized construction involved in the present matter comes under his jurisdiction. He submits that some occupants already filed Writ Petition in High Court for compensation. He submits that the unauthorized construction carried out by occupants in this year. He submits that they already issued notices to the occupants and also given them personal hearing & passed final order rejecting their stand. He submits that they already approached Dy. Commissioner of Police, Zone-4 Ulhasnagar for providing police protection. He submits that as soon as they get police protection, they will take appropriate steps immediately. He further submits that their advocate Mr Adsule is required some time to file the reply. Shri Promod B Kale, Dy. Chief Executive Officer, village Panchayat, Zilla Parishad, Thane filed their affidavit dated 28.10.2022. Same is taken on record & marked as Ex. 'A'. He submits that they are not concerned with this construction involved in the present matter. This fact also confirmed by Chief Executive Officer, Mr Borse of Badlapur Nagar Parishad. In view of above mentioned facts following order is passed.

a. Office is directed to issue summons to the Commissioner of Police, Thane calling upon him to file his affidavit when he can provide police protection to the Chief Officer, Badlapur Nagar Palika for taking appropriate steps in respect of unauthorized construction as per news appeared in Marathi News paper Samna dated 03.10.2022. Reply to be file on or before 30.11.2022.

b. Chief Officer, Badlapur Nagar Palika to file their detail reply along with copies of Writ Petition if any filed by occupant on or before 30.11.22. C. Chief Officer is directed to informed personally to the Commissioner of Police, Thane & explain him the entire matter so that he can file his reply in time & also to provide papers to him.

d. It is not necessary to call Chief Executive Officer, Village Panchayat, in Zilla Parishad, Thane to remain present matter till further orders. Matter to be appear on board on 30.11.2022."

3. Pending enquiry, an interveners application on behalf of affected shop owners came to be moved by Adv. Bhosale which came to be urgently taken up on 14.11.2022 and inquiry was pre-poned to an early date – 17.11.2022, however, on this date, on the request of Adv. Bhosale for the intervener and again on this date matter came to be taken up on the next succeeding date – 18.11.2022. Detail affidavits alongwith documents and copy of the order of High Court in Writ Petition came to be placed on record by Chief Officer Shir Yogesh Godse, Kulgaon Badlapur Municipal Council, Badlapur. Directions passed on these two dates are relevant for our purpose and reproduced in verbitam as under:

"14.11.2022:

Not on board. Taken on board.

- 2. At the request of Advocate Roshan Hule mentioned this matter for urgent orders. He submits that applicant filed application for intervention and to recall order dated 06.10.2022. He submits that the said order is affecting their rights. He submits that Kulgaon Badlapur Nagar Parishad demolishing their structures on or before 18.11.2022. Hence, there is urgency. Therefore, following order is passed:
 - a) Applicant is directed to serve by hand delivery the entire application (page 1 to 62) on the Addl. Chief Secretary (Panchayat Raj and Rural Development), Mantralaya, Mumbai and Chief Officer, Kulgaon Badlapur Nagar Parishad, Badlapur, Thane on or before 2.00 p.m. 15.11.2022 and file affidavit of service."
 - b) Matter to appear on board before Court no. 1 on 16th November, 2022 at 11.00 a.m. subject o service on other side within time."

"17.11.2022 PROCEEDING

(Per: Shri. M.A. Sayed, Hon'ble Member)

2 Ld. Advocate Mr. K. Bhosale on behalf of the interveners is present and Chief Officer Shri. Yogesh Godse, Kulgaon Badlapur Municipal Council is present.

- 3. Heard the parties at length.
- 4. The controversy seems to be having checkered history. According to Shri. Godse the alleged structures in question were demolished in 2016 itself since the area was required for road widening and some part of it was required by the railway department for extension of Badlapur platform. According to him an affidavit to that effect was already filed before High Court of Judicature at Bombay in Writ Petition No. 9561/2017, 7558/2017 and 7349 of 2017. Admittedly in these petitions three owners of the tenements / structures Smt. Laxmi Narayan Banjan, Shri. Vishwanath G Shinde and Shri. Jagdish Gajanan Shinde succeeded in establishing their title and possession over the open parcel of land by submitting their documents of title, sale deed etc and therefore, the concerned Municipal Council and the Railway Department were directed to pay compensation and the compensation is not yet paid as the proceeding is still subjudice before the land acquisition officer, Ulhasnagar. A very assertive statement is made by Mr. Yogesh that the entire alleged illegal structure were demolished in the year 2016 itself as mentioned above and the affidavit to that effect is submitted before High Court. He has undertaken to submit the copy of the affidavit, by tomorrow. Further Ld. Advocate Mr. Bhosale have moved the application on behalf of as many as 18 owners and Chief Officer Mr. Godse has made a submission at bar that all these owners were issued with notices in accordance with law, were called upon to submit legal documents in support of their respective claim and after due consideration their representation were rejected by him vide order dated 18.10.2022. In fact he also initiated the steps for demolition with the police aid, which he could not get because of Diwali vacation and inability of the police officials. It is submitted that pursuant to the directions passed by the Commission on previous date, he has personally approached the Commissioner of Police and apprised him of the present matter and the directions issued by us and could get the police protection, for today and tomorrow.

5 Considering the urgency expressed by the Ld. Advocate Mr. Bhosale we are adjourning the matter till tomorrow and call upon the Chief Officer Godse to submit his affidavit along with the copies of the affidavit filed in High Court in the writ mentioned above as well as the relevant record of the interveners before us and share the copies in advance.

6. Matter to appear on board before Court No.1 on 18th November 2022 at 11.00 a.m."

Accordingly, today an affidavit dated 29.11.2022 duly affirmed by CEO Yogesh Godse affirming in para 5 as under:

"5. I say that, I have attended hearing on 16/11/2022 before this Hon'ble Court. I further say that, we have carried out demolition work on 18/11/2022 with the help of police staff and entire illegal and unauthorized shops, galas, structures, are demolished. Since, the action has been taken by the Kulgaon-badlapur Nagar Parishad and entie illegal and unauthorized shops, demolished, therefore, nothing survives in the present Petion/ Suo Motu Cas No. 3871/13/30/2022, and hence, I pray that, the present petition Suo Motu Case/ Petition be disposed of as dismissed. Photo copies and news published in the local newspapers, of the above mentioned demolished shops, galas, structures are hereto annexed and marked as Exhibit "A"."

- Thus bare reading of the above affirmed statement indicates that the issue raised in the news reporting came to be rectified by carrying out the demolition operation under police protection by the civic authority thereby resolving the subject matter for good.
- In such backdrop, the plea and the prayer moved on behalf of the interveners - affected shop owners represented through Adv. Bhosale does not survive for consideration as having become infructuous in view of the concrete action taken by the Municipal Council. Be that as it may, these intervenors have liberty of exhausting remedy of redressing their grievances by approaching appropriate forum provided under the law.

Accordingly nothing survives in the present suo motu matter for further enquiry or intervention, hence closed and disposed off.
