एमआयडीसीच्यां मोकळ्या भूखंडावर, उच्च दाबाच्या विद्युत वाहिन्याखाली असणाऱ्या जागेवर शहरातील वाहतुकीच्या मार्गावरील मोक्याच्या 6 ठिकाणी (रोपवाटिका) व्यवसाय अनधिकृतपणे सुरू आहे. या नर्सरी या राजकीय नेत्यांच्या आर्शिवादाने साकरण्यात आल्या असून त्यांचे देखील यामध्ये हात ओले होत आहे. या नर्सरी मध्ये आकर्षक फुलाफळांची झाडे,कलमे अशी १०० ते २०० जातीची रोपे विक्रीसाठी आहेत. मात्र कोणत्याही प्रकारची परवानगी न घेता अनेकांनी व्यवसाय थाटले आहेत, अशा व्यावसायिकांवर कारवाई करण्याची मागणी नागरिकांकडून होत आहे.

 - 3. It is also stated in the said news that several times complaints made about such encroachment, but Corporation failed and neglected to take any action.
 - 4. Hence, Commission decided to take up this issue by way of Suo Moto complaint under Section 12 of The Protection of Human Rights Act, 1993 because encroachment on footpath

and road is affecting the human rights of the several people

- 5. Hence, following order is passed:
 - a) Office is directed to issue summons to the Municipal Commissioner, Navi Mumbai Municipal Corporation and Managing Director, Maharashtra Industrial Development Corporation calling upon them to hold fact finding inquiry and submit the report on or before 25.04.2023.
 - b) Matter to appear on board before Division Bench of Justice K.K. Tated, Chairperson and Shri. M. A. Sayeed, Member in Court No.1 on 25th April 2023 at 11.00 a.m.

ORDER

(Per: M. A. Sayeed, Hon'ble Member)

Marathi local newspaper 'Pudhari' of 28.03.2023 focused on indifferent attitude and apathy on the part of MIDC and Municipal Corporation in initiating appropriate damage control steps against the squatters mostly the nursery vendors on footpath and open area in Navi Mumbai.

2. Pursuant to our suo motu cognizance, motice taken by invoking powers u/s. 12 of the Protection of Human Rights Act and detail order dated 29.03.2023, reports by the respondents at Ex. 'A' & Ex. 'B' came to be placed on record. The respondent municipal corporation sought to be exonerated from any liability on the ground that the said

area in question falls within the jurisdiction MIDC - corespondent, while on the other hand co-respondent MIDC vide affidavit Ex. 'B' dated 24.04.2023, attempted to clarify the issue, by affirming in para 3 & 4 as under:

"3. I say that the nursery in the said plot was set up by a person claiming to be erstwhile owner of the portion of land. After following due process of law the said person was removed alongwith his articles from the said plot. However, the said person has again encroached some portion of land and MIDC have initiated legal action to remove the said person after following due process of law.

4. I say that apart from this plot no other area under MIDC has been encroached by any person carrying out nursery activity."

Photographs of the site, depicting the steps taken for removal of the unauthorized structure with nursery plants etc are annexed with this report Ex. 'B'.

3. We are satisfied with the reports placed on record and therefore proceed to pass following order:_
"ORDER"

a) Present suo motu stands closed and disposed off with no order as to cost.
