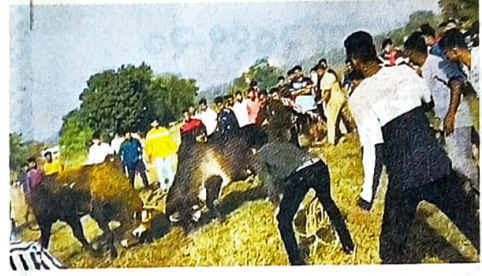

2. We noticed news appeared in Marathi news paper lokmat dated 05.11.2022, page 5 with title “बंदीनंतरही माणरेमध्ये रंगल्या बैलांच्या झुंजी; व्हिडीओ सोशल मीडियावर व्हायरल”.

3. It is stated in the said news that in Ulhasnagar Camp No.4, Maner Village is there, in that village in Sukala Ground villagers arranged Bullocks fight, which is banned in Maharashtra. But inspite of that Police Authority failed and neglected to take appropriate action.

4. Considering these facts the following order is passed:

- a) Office is directed to issue summons to the Collector, Thane, Commissioner of Police, Thane (Rural) and Municipal Commissioner, Ulhasnagar Municipal Corporation calling upon them to hold inquiry and submit

1. Advocate Mr. S. D. Shinde filed his vakalatnama on behalf of Kalyan Dombivili Municipal Corporation. Same is accepted.

2. Assistant Police Inspector Shriram Anandrao Padwal from Hill Line Police Station filed report dated 28.03.2023. Same is

taken on record and marked as Exhibit – 'C'. It is stated in the said report that they already taken cognizance of the same and registered offence under Section 11(1) (n) of Prevention of Cruelty to Animals Act and under Section ¹⁸⁸ Indian Penal Code. ~~188~~. He submits that charge sheet is also filed. To that effect he is relying on their earlier report dated 02.03.2023 Ex.'B'.

3. Advocate Mr. Shinde filed affidavit dated 24.03.2023 of Commissioner, Kalyan Dombivili Municipal Corporation. Same is taken on record and marked as Exhibit – 'D'.

4. Advocate Mr. Bhavesh Magam for Ulhasnagar Municipal Corporation also filed affidavit dated 25.03.2023. Same is taken on record and marked as Exhibit – 'E'.

5. Both the counsels submit that inadvertently remained on their part to comply the summons issued by this Commission. They submits that in the interest of justice this Commission be pleased to recall the notice under Section 166A of Indian Penal Code. Considering the submissions made by both the Counsels and averments made in Ex. 'D' and 'E' ^{we} is satisfied to recall the said notice in the interest of justice.

6. Advocate for Ulhasnagar Municipal Corporation submits that the said incidence took place in the area which comes under Kalyan Dombivili Municipal Corporation. Statement is accepted

7. Advocate Mr. Shinde submits that in future they will take appropriate steps to prevent such incident. Not only that they decided to take legal action against the owner of the said plot of land after following due process of law. Statement is accepted.

8. In view of above mentioned facts, the following order is passed:

- a) Suo Moto case stands closed and disposed of in view of subsequent developments.
