- 4. Considering these facts Commission decided to take up this matter as a Suo Moto under Section12 of the Protection of Human Rights Act, 1993.
- 5. Hence, following order is passed:
 - a) Office is directed to issue summons to Municipal Commissioner, Vasai Virar Municipal Corporation, Vasai and Collector, Palghar calling upon him to hold inquiry

and submit the affidavit in reply before this Commission on or before 21.12.2022 on following points:

- Description of the property described in article appeared in Marathi Newspaper Lokmat dated 07.12.2022.
- ii. Copies of the sanctioned plan of the said structure.
- iii. Copies of the notice if any issued for removing unauthorized construction.
- iv. Name of the developer builder who constructed the said structure
- v. On what basis the said structure is unauthorized?
- vi. What is the area of the land on which the said structure is constructed?
- vii. What is the permissible area of the construction of the said land and how much exactly is constructed?
- viii. If it is unauthorized why action is not taken till today?
- d) Matter to appear on board before Division Bench of Justice K.K. Tated, Chairperson and Shri. M.A. Sayeed, Member in Court No.1 on 21st December 2022 at 11.00 a.m.

<u>ORDER</u>

(Per: M. A. Sayeed, Hon'ble Member)

A news article in Marathi local newspaper 'Lokmat', highlighted on the apathy on the part of the Corporation and arrogance on the part of the squatters in removing their illegal structures despite issuance of legal notice to them by the Corporation.

2. Considering the gravity of the news article, suo motu cognizance u/s. 12 of the Protection of Human Rights Act came to be taken by the Commission. Pursuant to our directions dated 24.02.2023, report on affidavit Ex. 'B' dated 11.04.2023 came to be placed on record, affirming in para 1 Clause (a) to (c) as under:

"a. I further say that the Municipal corporation of Vasai Virar has demolished the temporary illegal shade pertaining to premises in question ie. Mehefil Restaurant on 14/03/2023. Hereto marked and annexed is the copy of photos of demolition drive of conducted by Vasai Virar City Municipal Corporation As exhibit – A.

b. I say that as per direction of the Hon'ble Commission a cost of Rs.10000 (rupees ten thousand only has been also paid to the chief minister relief fund on 05/04/2023 Hereto marked and annexed is the

copy of receipt As exhibit -B.

c. I further state that the Mehfil Restaurant falling in the jurisdiction of the Municipal corporation of Vasai Virar has is running with a proper license. Which are annexed As exhibit - C"

Pertinent to note that photographs of the site, depicting removal of the illegal construction came to be annexed with the affidavit Ex. 'B'.

3. Thus, with the issue having come to its logical end due to appropriate legal action by the Corporation, we are of the opinion that the present suo motu deserves to be closed.

Ordered accordingly.
