मुंबई : मालाड पश्चिम लिंकरोडवरील हॉटेल्ससह इतर ठिकाणी दाखल होणाऱ्या ग्राहकांकडून दुचाकी, चारचाकी वाहने लिंकरोडवर उभी केली जातात. विशेषतः सायंकाळी ७ ते रात्री ९ यावेळेत येथे मोठ्या प्रमाणावर पार्किंग होते. आणि यामुळे रस्ता अरुंद झाल्याने वाहनांना पुरेशी जागा मिळत नाही. या कारणास्तव येथे मोठ्या प्रमाणावर वाहतूक कोंडी होत वाहनांच्या लांबलचक रांगा लागतात. याच फटका नागरिकांसह इतर



वाहनचालकांना बसतो. वाहतूक विभागाने याप्रकरणी कारवाई करावी म्हणून फाइट फॉर राइट फाउंडेशनचे अध्यक्ष विनोद घोलप यांनी कित्येकवेळा ही बाब निदर्शनास आणून दिली आहे. सोशल

माध्यमांच्या मदतीने या समस्येवर प्रकाश टाकण्यात आला आहे. गोरगाव वाहतूक विभाग, परिवहन आयुक्तांना लेखी निवेदन दिले आहे. लिंकरोडवरील वाहतूक कोंडीतून नागरिकांची सुटका करण्याची मागणी केली आहे. मात्र प्रशासकीय यंत्रणा काहीच कारवाई करत नसल्याने समस्येचा गुंता सुटण्याऐवजी वाढतच आहे. दरम्यान, अनधिकृत पार्किंग प्रकरणात योग्य कारवाई झाली नाही तर आंदोलन छेडले जाईल, असे म्हणणे संघटनेने मांडले आहे.

Not on board. Taken on board.

1. We noticed news appeared in Marathi News paper Lokmat (Hello Mumbai) dated 06.01.2023 on Page 1 with heading "मालाड लिंकीरोडची कोंडी फुटेना" .

2. It is stated in the said news that because of unauthorized parking and stalls it is very difficult for the public to move from the linking road, neither Corporation nor Police Authority is taking any action. Day by day parking on both the sides of the road is increasing.

3. Considering these facts stated in the said news, Commission decided to take up this matter as suo moto under Section 12 of the Protection of Human Rights Act, 1993. Hence, following order is passed:

a) Office is directed to issue summons to the Additional Chief Secretary, Home Department, Mantralaya, Mumbai

and Municipal Commissioner, Municipal Corporation of Greater Mumbai, Mumbai calling upon them to hold inquiry and file their affidavit in reply before this Commission on or before 02.02.2023.

- b) **Matter to appear on board before Division Bench of Justice K.K. Tated, Chairperson and Shri. M. A. Sayeed, Member in Court No.1 on 2nd February 2023 at 11.00 a.m.**

ORDER

(Per: M. A. Sayeed, Hon'ble Member)

City edition of 'Lokmat' - 'Hello Mumbai' dated 06.01.2023, published an article, which primarily focused on severe inconvenience faced by public in general in approaching Link road, Malad because of illegal parking and hawkers stall. Considering the gravity of the matter suo motu action came to be taken by the Commission by invoking powers u/s. 12 of the Act of 1993 vide order 06.01.2023.

2. Reports on affidavit came to be placed on record during course of inquiry by the respondents and eventually in compliance of our direction dated 02.02.2023, report on

affidavit came to be submitted by Asst. Engineer, Traffic Department, MCGM, vide Ex. 'B'. On going through the affidavit it appears that damage control steps viz. Installation of no parking signs, came to be installed at New Linking Road, Malad (W) and Goregaon (W) as well as steps were also taken to remove the illegal hawkers from the Link Road thereby resolving the issue once for all. The police has also prepared a Traffic Signage Plan so as to control and prevent repetition of such illegal activities on the road, thereby avoiding inconvenience to the public in general. Photographs vide annexure I & II are also filed with the report Ex. 'B'.

Accordingly, we have no hesitation to hold that with the issue being resolved our further intervention is not warranted, hence, present suo motu stands closed and disposed off.
