Maha ACP booked for molestation, stalking

Aurangabad: A serving assistant commissioner of police (ACP) with the Aurangabad city police has been booked on the charge of molesting and stalking a 30-year-old woman and creating a ruckus while forcefully ente-ring her house between 1.45am and 2.30am on Sunday. The ACP is also accused of abusing and slapping the woman's husband and getting physical with the couple's neighbours and relatives when they tried to intervene during a 45-minute drama in the early morning hours.

The woman's husband dialed 112 and a police team reached the spot and took the ACP along with them. The City Chowk police station registered a first information report (FIR) almost eight-and-ahalf hours later and did not refer the ACP to a medical test. "The police were initially reluctant to register a case. It was only after MLC Ambas Danve's intervention that they relented," he alleged.

When contacted, Aurangabad police chief Nikhil Gupta told TOI, "I have no comment to offer, but we will soon issue a statement on this matter."

Later, Aurangabad city crime branch inspector Avinash Aaghaav issued a statement that read: "Based on the affected woman's complaint, a case for offences under Section 354 (outraging modesty), 354-A (sexual harassment), 354-D (stalking), 452 (house trespass) 323 (causing hurt), 504 (intentional insult) and 506 (criminal intimidation of the Indian Penal Code has been registered."

The statement read, "The investigation of the case has been handed over to the deputy commissioner of police (zone II) Shilwant Nandedkar. The ACP has been moved out with immediate effect from his present posting to a new assignment."

When contacted, the ACP told TOI, "I am being fulsely implicated as I am investigating a sensitive case and had already informed the police chief about such a possibility."

- 1. We noticed news appeared in English News paper dated 16.01.2023 on page 12 with heading "Maha ACP booked for molestation, stalking" and in Marathi news paper Lokmat dated 16.01.2023 on page 1 with heading "'एसीपी' चे महिलंशी कारमध्ये अश्लील चाळे"
 - It is stated in the said news article that a serving Asst.
 Commissioner of Police (ACP) with the Aurangabad City Police has been booked on the charge of molesting and stalking a 30-year old women at her house between 1.45 a.m. and 2.30 a.m. on Sunday 15.01.2023.
 - 3. It is also stated in the said news that City Chowky Police Station registered F.I.R. almost 8 ½ hours later and did not refer the Asst. Commissioner of Police to a medical test. The Police were initially reluctant to register a case. It was only after MLC Ambas Danve's intervention that has been registered.
 - 4. It is very shocking that a Police Officer of cadre Asst. Commissioner of Police committed so serious offence and City

Chowky Police Station registered F.I.R. after more than eight hours. Apart from the Police Authority has not taken the said instance seriously.

- 5. Considering these facts it is necessary to take up these issues under Section 12 of the Protection of Human Rights Act, 1993 as Suo Moto case, as same is affecting the human rights of several people. Hence, the following order is passed:
 - a) Office is directed to issue summons to the Additional Chief Secretary, State of Maharashtra. Department. Home Mantralaya, Mumbai Commissioner of and Aurangabad directing them to hold fact finding immediately and submit report in any case on or before 31.01.2023. He is further directed to place on record CCTV footage of the said incident without fail on next date.
 - b) Commissioner of Police, Aurangabad is directed to inform the victim's family about this order and also inform them, if they want they can also file their say in the present matter.
 - c) Matter to appear on board before Division Bench of Justice K.K. Tated, Chairperson and Shri. Bhagwantrao D. More, Member in Court No.1 on 31st January 2023 at 11.00 a.m.

DCP filed report dated 01.03.2023 which is marked as Ex.' B'.

- 2. The present proceeding initiated u/s.12 of the Protection of Human Rights Act, 1993 on the basis of news appeared in Marathi Newspaper "Lokmat" dated 16.01.2023 page 1 with title " एसीपी चे महिलेशी कारमध्ये अश्लील चाळे".
- 3. As per order dated 16.01.2023 police authority submitted report dated 13.01.2023 Ex.'A' & 01.03.2023 Ex.'B'. DCP submits that they registered Crime No.27/2023 on 15.01.2023 u/s.354,354-A,354-8,452,323,504& 506 of I.P.C. He submits that they immediately arrested the accused Mr.vishal Dhume who was working as A.C.P. He submits that Shri Dhumal approached to the Judicial Magistrate, Court No.3 Aurangabad by way of bail application. He submits that after considering documents on

record the Ld Judicial Magistrate granted bail. Operative part of the order of bail dated 16.01.2023 read thus:

- 1."Bail application is hereby allowed."
- 2. "Accused is hereby released on P.B. and S.B. of Rs 25,000/-.
- 3."Accused shall not temper the evidence of prosecution & shall not abscond from the jurisdiction of this Court."
- 4."He shall assist the police agency in investigation if necessary."
- 5."He shall not pressurized the informant & the witnesses".
- 4. D.C.P. further submits that departmental enquiry initiated against accused Dhume & he suspended. It is to be noted that now the matter is pending in Court & also departmental enquiry is going on & no one represented on behalf of victim inspite of intimation. There is no question of continuing with this Suo-Motu complaint. Hence following order

Suo-Motu complaint stands closed & disposed off.
