## Give us a recreation centre: Vashi seniors

Senior citizens' forum demands that construction restarts on the centre in Vashi's Sector 17 garden that was stopped by the NMMC two years back; civic body suspended work allegedly after objection from a Congress leader

AFTER an objection to the construction of a recreation centre in its garden, the Navi Mumbai Municipal Corporation (NMMC) stopped build-ing one in Vashi Sector 17 two years back. However, a senior citizens' forum from Sector 17 has demanded construction be restarted, as they are facing is sues due to the absence of the recreation centre.

"The NMMC had begun construction on a recreation centre in Meenatai Thackeray garden. But after construction began in 2019, it was stopped," said former corporator Sampat Shewale.

Shewale said the Sector has around 3,500 senior citizens. "Most of them live alone as their children work in other cities. This recreation centre can help them spend their time," another local resident

We have followed up with the NMMC repeatedly. However, the work has not restarted yet. There is a recreation centre in every sector of NMMC in its gardens. But it has stopped work only of this centre," said. Niranjan Desiger, president of Maharaja Senior Citizens' Forum, which has appealed to NMMC to resume construction of the centre.

"According to NMMC rules one recreation centre can be built in an area of 2 square kilometers. There are 3 recreation centers nearby. Even local people are opposing this recreation center. The garden space is limited. After the construction of the recreation centre, it will be reduced. They should choose another location to construct a recreation centre," Congress leader Anil Kaushik, who opposed the recreation center in the garden.

#### PROCEEDING

(Per: Justice K. K. Tated, Hon'ble Chairperson)

Advocate Vishal Shirke for Navi Mumbai Municipal Corporation is present.

Advocate Vallari Jathar with Mr. Anil Kaushik for Intervener is present.

- 1. The present suo moto initiated on the basis of news appeared in English dated 18.10.2022 under heading "Give us a recreation centre: Vashi seniors".
- 2. Pursuant to the notices issued to the Corporation they filed their affidavits and stated that they have already given contract to M/s. So Best Services to complete the remaining work.

- 3. Today Advocate for Corporation filed affidavit dated 11.03.2023 of Mr. Somanth Kekan, Asst director of Town Planning, Navi Mumbai Municipal Corporation stating that whatever construction they are doing is within four corners of law. He relied on para 7,9 and 10 of Ex. E which reads thus:
  - "7. I further say that the total area of the Meenatai Thakarey garden is 8026.56 square metres. The total proposed construction of the recreation centre is about 45.44 metres."
  - "9. I further say that the total area of construction of the recreation centre is 45.44 square metres and the total area of the garden is 8026.56 square metres. Thus, the total area of the proposed recreation centre is roughly 0.56% of the total area of the garden. This falls well within the prescribed limit of 1% provided for in the DCR. Thus, the entire construction falls well within the parameters of law as prescribed in the DCR."
  - "10. I further say that the garden also has an existing gazebo (which is open from all sides and has FRP sheet roofing) admeasuring 34.19 square metres. The garden also has a small Niwara shed which is admeasuring 17.01 square metres. There is also a small moveable watchman's cabin which admeasures 3.40 square metres. All three of these structures are temporary in nature. There are no walls to the Gazebo and the Niwara shed. They only consist of fibre sheets for the roof in order to protect the senior citizens from rain and harsh sunlight. Copies of photographs in this regard are annexed hereto and marked as Exhibit-C (Colly)."

- On the other hand Mr. Kaushik vehemently opposed these facts. He submits that Corporation is misguiding the Corporation.
- 5. I don't think any further investigation is required. The Intervener is at liberty to take appropriate, action against Corporation according to law. Now nothing survives in the present complaint. Hence, following order is passed:

a) Suo Moto case stands closed and disposed of with liberty to the Intervener as stated hereinabove.
