**PROCEEDING**

1. Perused the newspaper report dated 25.09.2025 in Mumbai Edition and daily Maharashtra Times. Averment in the newspaper report is to the effect that in the Buffer Zone of Tadoba Andheri Tiger Project and more particularly, at Sitaram Peth in Moharli Range, a Tiger has killed a person working in the field. Occupation of that person is stated to be the driver of the Gypsy Car. Newspaper report is further stating that in past nine days, four persons died in Tiger attack in Chandrapur District of the State. It is averred that the said person Amol Baban Nanaware aged about 38 years had been to the agricultural field for giving motor pump to his father where he was killed by the Tiger. It is averred that such incidents of killing human being



occurred in the District on 16.09.2025, 18.09.2025, 19.09.2025 as well as on 24.09.2025 also.

2. If averments made in this newspaper reports are found to be true then a case of serious violation of right to life is made out as the incidents reported appears to have taken place in an agricultural field and not in the area of National Park – Core Area or Buffer Area.

3. The case for taking suo moto cognizance is made out as larger interest of the residents in the District has kept in mind because such incidents amounts to threat to the right of life bestowed by the Constitution of India. The Commission will have to examine what steps are taken by the Wild Life Wing of the Forest Department, State of Maharashtra to curb this menace and loss of human lives in such incidents. It will also have to be found out whether the next of kin of such victims of man-animal conflict are adequately compensated or not. Hence, by taking cognizance of the matter suo moto as per provisions under the Protection of Human Rights Act, 1993. Hence, following order:


- a) Issue notice of this proceeding to the Principal Secretary, Revenue and Forest Department, Mantralaya, Mumbai, Principal Chief Conservator (Wild Life) Maharashtra State, 3<sup>rd</sup> Floor, Van Bhavan, Ramgiri Road, Civil Lines, Nagpur and the Field Director, Tadoba Andheri Tiger Project, Mul Road, Chandrapur – 442 401. Report to be furnished by 07.10.2025, failing which matter shall proceed exparte by ordering payment of suitable compensation assessed by the Commission and by directing the steps to be taken for



prevention of such incidents apart from other recommendations.

### ताडोबाच्या मोहली वनपरिक्षेत्रातील घटना

नव्याने चर्चेला आला आहे.

भद्रावती तालुक्यातील भामडेळी येथील रहिवासी असलेला अमोल बबन नन्नावरे हा ३८ वर्षीय ताडोबा-अंधारी व्याघ्रप्रकल्पात जिप्सीचालक म्हणून काम करत होता. भामडेळी येथील गट क्रमांक-४ मधील शेतामध्ये तो सकाळी त्याच्या वडिलांना शेतात फवारणी करण्यासाठी मोटारपंप

देण्यासाठी गेला होता. त्याचवेळी जवळच भक्ष्याच्या शोधात लपून बसलेल्या एका वाघाने अचानक त्याच्यावर हल्ला केला.

नऊ दिवसांत चार घटना

- १६ सप्टेंबर : उत्तर ब्रह्मपुरी वनपरिक्षेत्रात वाघाच्या हल्ल्यात गुराखी ठार.
- १८ सप्टेंबर : चिमूर प्रादेशिक वनपरिक्षेत्रात वाघाच्या हल्ल्यात महिला ठार.
- १९ सप्टेंबर : गडबोरी येथे सात वर्षांच्या मुलाला विबळ्याने ठार मारले.
- २४ सप्टेंबर : मोहली वनपरिक्षेत्रात वाघाच्या हल्ल्यात जिप्सीचालक ठार.
