Take note that in default of your appearance on the day mentioned above, the matter will be decided further in accordance with law.

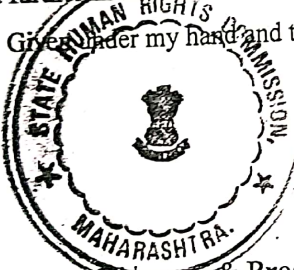
