ORDER

1. Heard the learned Counsel for the complainant. None appeared for the Respondent.
2. The learned Counsel for the complainant argued that the Municipal Corporation had issued notice under Section 314 of Municipal Act and the Health Department also issued notice under Section 28 of the Municipal Act but no further action is taken. It is argued that further notice is also issued by the Health Department.
3. The learned Counsel for the Municipal Corporation of Greater Mumbai is absent and hence perused the affidavit filed by the Municipal Corporation of Greater Mumbai. It is stated in para 4 and 5 of the said affidavit that the Municipal Corporation has issued notice u/s 314 of the Municipal Act to the owner of the shop and they are following due process of law.
4. In this view of the matter the following recommendations:
 - a) The Municipal Corporation of Greater Mumbai to take action according to law as stated in their affidavit expeditiously.
 - b) With these recommendations complaint is closed.
